

# COMPETITION RULES 2024

## *A Special Winning*

### 1. PROMOTER

Seven Media Code LTD with registered office at Strovolou, 77, Strovolos Center, Flat / Office 301, Strovolos, 2018, Nicosia, Cyprus (hereinafter the "Promoter").

### 2. NAME OF THE COMPETITION

"A Special Winning" (hereinafter, the "Contest")

### 3. DURATION

The competition will last from 01-02-2024 - 30-01-2025 with draw performed in terms of 60 days.

### 4. OBJECT OF THE PROMOTION

### 5. TERRITORIAL SCOPE

Entire territory of Europe, Americas, Asia and Australia, broken down by country specified in the link of participation, by subdomain, name specification and geo validations.

### 6. RECIPIENTS

All adult users (18+) (hereinafter the "Recipients")

### 7. HOW TO PARTICIPATE AND PRIZES TO BE GIVEN

To participate in the final draw, users must connect to the site, also available in the mobile version, and fill out the registration form in all its fields.
